All REALTOR® members of CBR who meet the criteria below and are willing to fulfill the scholarship requirements are encouraged to apply by **March15th.** A panel of four (4) past Presidents of the CBR selected by the current CBR President and the current CBR President will review all submitted applications and select recipients to be announced on or before **April 1st**.

## **Applicant Requirements:**

- Applicant must be a current CBR REALTOR® member at the time of application and meeting dates.
- Applicant must demonstrate a commitment to professionalism, volunteerism, and a desire to develop leadership skills.

# The Selected Recipient would be required to:

- Attend the meeting indicated on their application.
- Meet with the CBR Leadership Team prior to the meeting indicated on their application to determine what is covered by their scholarship, review the requirements, and discover important sessions to attend while at the meeting.
- Post daily while at the meetings to the CBR Member Facebook Group. (*NOTE: posts should be about the meetings and experiences they are attending, not the sites they are seeing and food they are eating*).
- Submit a report about their experience to the CEO to be shared with the CBR membership within 2 weeks of the meeting end date.
- Submit all receipts for reimbursement no later than 30 days after attending the meeting.
